MADE ON SALT SPRING will not be responsible for any costs, damages or economic loss resulting from your failure to comply with this term. If any government agency, court, person or commercial body orders sale of your products to cease, you will immediately comply with this order.
  - ➔ You will indemnify MADE ON SALT SPRING for any loss, fine, penalty, judgement, legal fees and expenses reasonably connected with your failure to comply with the terms of this agreement or any liability, negligence, gross negligence or injury resulting from your products, actions, conduct, booth setup, display or trade activities.
  - ➔ MADE ON SALT SPRING does not warrant or represent that any particular booth size or option will be available to you at the time of registration. MADE ON SALT SPRING may change your booth size or the availability of options at its sole discretion and will refund the difference between the amount you have paid and the value of the revised booth and options within a reasonable period of time.
  - ➔ If you fail to comply with the terms of this agreement contained herein and as amended or updated from time to time, whether before or during the show, MADE ON SALT SPRING may cancel your application or remove you and prohibit your attendance at the show. The refund policy will apply to the cancellation of your application or participation in the show unless any damages or losses suffered by MADE ON SALT SPRING as a result of your breach exceed the price of your booth, less any applicable refund. Any damages in excess of your booth rental fee suffered by MADE ON SALT SPRING as a result of your breach of this agreement shall become immediately due and payable to MADE ON SALT SPRING
